

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.gainretainthrive.com, and GRT Marketing and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to GRT Marketing include www.gainretainthrive.com, under the Retention Wizard, LLC. The GRT Marketing website is a small business marketing strategy site. By using the GRT Marketing website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, GRT Marketing may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase GRT Marketing's services, we collect billing and credit card information. This information is used to complete the purchase transaction.

GRT Marketing may also collect anonymous demographic information, which is not unique to you, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

GRT Marketing collects and uses your personal information to operate and deliver the services you have requested.

GRT Marketing may also use your personally identifiable information to inform you of other products or services available from GRT Marketing and its affiliates.

Sharing Information with Third Parties

GRT Marketing does not sell, rent or lease its customer lists to third parties.

GRT Marketing may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to GRT Marketing, and they are required to maintain the confidentiality of your information.

Automatically Collected Information

Use of Cookies

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our
